

TERMS OF USE

1. Acceptance of Terms

THESE TERMS AND CONDITIONS MAY HAVE CHANGED SINCE YOUR LAST VISIT TO THE SITE. BY USING THE SITE YOU INDICATE YOUR ACCEPTANCE OF THESE TERMS AND CONDITIONS.

Club Sparkle USA (collectively “Club Sparkle” or “we”, “us”, “our”) provides access to the Club Sparkle web site, located at www.clubsparkleusa.com (the “Site”) subject to your acceptance of these TERMS AND CONDITIONS (“Agreement”). Club Sparkle may update these TERMS AND CONDITIONS from time to time without prior notice to you. We encourage you to review these TERMS AND CONDITIONS periodically for any updates or changes.

By accessing, browsing, framing, using and/or linking to the Site, you become a User (defined herein in Section 2) and agree to be bound by the terms of this Agreement. When using a particular feature of the Site, you may also be subject to any posted guidelines, rules, terms of service, acceptable use policies, privacy policies, or other contractual provisions as noted. 2. Types of Users

Any person accessing, browsing, or otherwise using the Site, either manually or via an automated device or program, shall be deemed a “User” under this Agreement.
